ARTICLE I - NAME

The name of this corporation is ACME SELF STORAGE, INC. located at 4565 Helena Drive, Titusville, FL 32780.

ARTICLE XIII - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.


