ARTICLES OF AMENDMENT

OF

AIRPORT INFORMATION NETWORK, INC.

PURSUANT TO SECTION 607.1006 OF THE FLORIDA BUSINESS CORPORATION ACT, THE UNDERSIGNED CORPORATION ADOPTS THESE ARTICLES OF AMENDMENT.

FIRST:

THE NAME OF THE CORPORATION IS AIRPORT INFORMATION
