ARTICLE I-NAME

The name of the corporation is Cargo Risk Managers

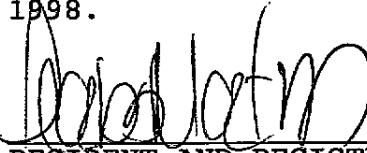
