The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I: Name

The name of the corporation shall be Fresh Start Maintenance, Inc.

Article II: Principle Office

The principle place of business and mailing address of this corporation shall be 7 Loblolly Court, #205, Winter Springs, Florida 32708.

Article III: Shares

The corporation shall have the authority to issue 10,000 shares of stock.

The registered agent of the corporation is Paul Fudge, and the registered street address is 7 Loblolly Court, #205, Winter Springs, Florida 32708.


Article V: Directors
