ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporations Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE

The Corporate name is: FOOD, INC. 2,000

ARTICLE TWO

Duration

The duration of the Corporation is perpetual.

ARTICLE THREE

Purpose

The Corporation may transact any and all business which is in and related to the sale of foods and food products. Such sales will be provided primarily by retail restaurant trade. The Corporation may also engage in the sale of foods, food products and related products to individuals, to institutions and to businesses, at retail or wholesale, by any means allowed by Florida law.

ARTICLE FOUR

Capital Stock

The aggregate number of shares which the corporation has authority to issue is 10,000 all of which shall be common shares with a par value of ONE DOLLAR (\$1.00) per share.

ARTICLE FIVE

Registered Office

ARTICLE SIX

The business of the corporation shall be managed by a Board of Directors consisting of a minimum of one director and a maximum of six directors.
