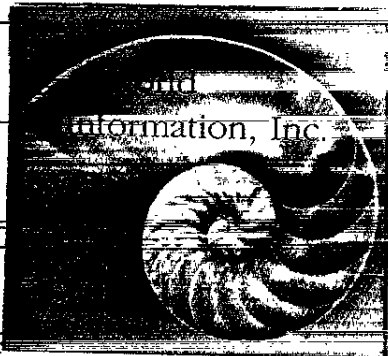

**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
TO  
WORLD INFORMATION, INC.**

*Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:*

**FIRST:** Amendment(s) adopted: *(indicate article number(s) being amended, added or deleted)*

Article to be amended is ARTICLE III CAPITAL STOCK

Amendment I of article III to read as follows: The total number of shares of stock that this corporation is authorizing to have outstanding at any one time is ten thousand (10,000) having no par value per share.

**SECOND:** If an amendment provides for an exchange, reclassification or cancellation of issued shares, provisions for implementing the amendment if not contained itself, are as follows:.


Parker Converse II and Howard Lee Singer shall each be issued thirty eight hundred (3,800) shares of common stock with no par value in exchange for the fifty shares (50) of common stock with a par value of one dollar (\$1.00).

**THIRD:** The date the amendment's adoption: May 15<sup>th</sup> 1999.

**FOURTH:** The amendment was adopted by the board of directors without shareholder action and shareholder action was not required.
