

ARTICLE ONE. NAME

The name of the corporation is SUPERIOR BENEFITS CONSULTANTS, INC.



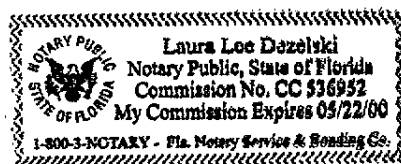
