**ARTICLE ONE**

The name of the corporation is FORCE AIR, INC. The principal office of the corporation is 12101 31<sup>st</sup> Court N., St. Petersburg, Florida 33716-1831.

**ARTICLE TWO**

The period of duration is perpetual.

The Board of Directors is empowered to make, alter or repeal the bylaws of the corporation without restriction of their powers conferred by statute.





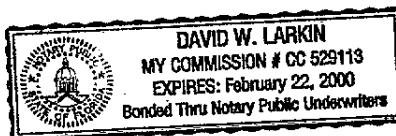
