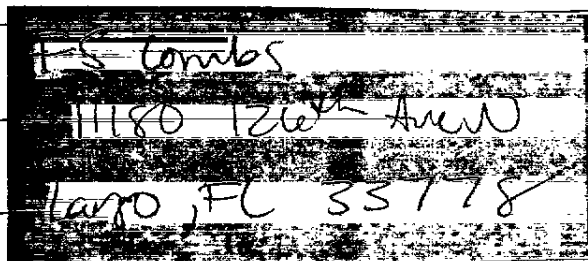

ARTICLES OF INCORPORATION

KEY WEST FRESH, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is Key West Fresh, Inc.

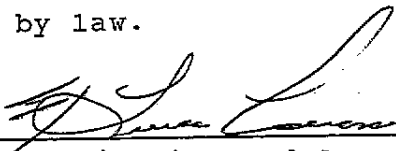
