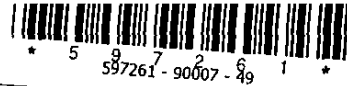

Dear Sir or Madam:

My name is Reynaldo L. Lopez. I am the President of NuBioChem Safety Corporation. This letter is in reference to the late filing penalty fee being charged to the corporation due to the gross negligence of Lazarus Filing Service Inc. in Miami.

On May 4 1999 I went to Lazarus Filing Service Inc to file the annual return electronically. I filled out the form changing the register agent information. An employee of listed Corporation had shaded the areas that needed to be completed. That same person checked the form for accuracy of the contents then kept the form. On July 14 1999 I checked with your department to verify that the Annual Report was filed on time. I was told that the report was returned on May 5 due to not being fully completed. A notice was sent to Lazarus Filing Service Inc to correct the signature line (box 11). They were given 30 days to send back the corrected form. I was never notified by any means of this incident. Due to this second negligence the form was never sent back in time.-

I am respectfully asking that the penalty fee be waved due to the gross negligence of Lazarus Filing Service Inc. Since NuBioChem Safety Corp. is a very small Corporation & recently established it's operating resources are very limited. If the the penalty fee is waved it will provide the Corporation with the means to continue operating & generating tax revenues to the State of Florida. Also it will provide future employment opportunities to the residents of Miami-Dade County.
