

**ARTICLES OF INCORPORATION
OF
MAUDI MAY, INC.**

THE UNDERSIGNED, desiring to incorporate a business corporation under the provisions of the Florida General Corporation Act does, hereby certify:

1. The name of the corporation is **MAUDI MAY, INC.**
2. The term for which the corporation is to exist is perpetual.
3. The general nature of the business to be transacted by the corporation shall be to engage in and do any lawful act permitted under the laws of the United States of America and of the State of Florida.
4. The aggregate number of shares of capital stock which the corporation shall have the authority to issue is 500 shares of common stock having a par value of \$1.00 each.



9. The formation of the corporation shall be effective as of the date of execution of these Articles by the Sole Incorporator.


