**ARTICLES OF INCORPORATION

ARTICLE ONE- NAME

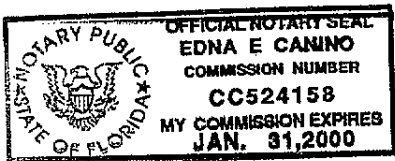

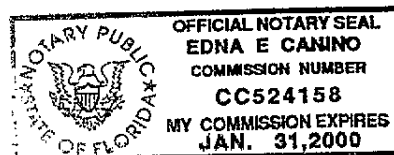
