ARTICLES OF INCORPORATION

Article I

The name of this corporation shall be :

M.V. IMPORT & EXPORT, CORP.

Article II

This corporation may engage in the transaction of any or all lawful business under the laws of the United States and the State of Florida.

Article III

The maximum number of shares of stock authorized to be issued by this corporation at any time is 7,500 shares of \$ 1.00 par value each.

Article IV

The shareholders of this corporation shall have preemptive rights to acquire unissued or treasury shares of the corporation, or securities of the corporation convertible into or carrying a right to subscribe to or to acquire shares of the corporation to the extent that the stockholders might so specifically set forth. Lacking this affirmative action by the stockholders there shall be no such preemptive rights.

Article V

This corporation is to have perpetual existence.

#### Article VI

The principal office of this corporation shall be located at : 245 SE 1 Street # 210 Miami, Florida, 33131. \_\_\_\_\_ with the corporation retaining the power of moving its office to any other address in Florida, as may from time to time be determined and authorized by its Board of Directors, with branch offices in such other cities, or countries as may from time to time be authorized by its Board of Directors.
