The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I. CORPORATE NAME

The name of this corporation is Fattahi Enterprises, Inc.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is: 41 South Palafox, Pensacola, FL 32501.

ARTICLE III. CAPITAL STOCK

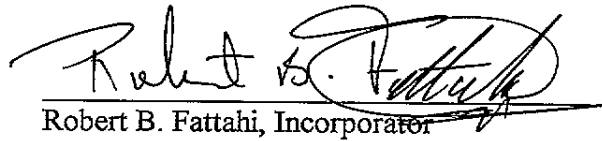
ARTICLE VI. DIRECTORS
