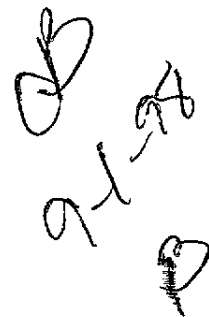

- ARTICLE I: The name of this corporation is **TOMMY GUNN, Inc.**
- ARTICLE II: The existence of the corporation shall begin on September 1st, 1998.
- ARTICLE III: The principal place of business of the corporation shall be 7741 N.W. 45th Court, Lauderhill, FL 33351.
- ARTICLE IV: The maximum number of shares this corporation is authorized to issue is One Hundred (100), all of which shall be common shares.
