Pursuant to Pursuant to Article 5.04 of the Texas Business Corporation Act (the "Texas Act") and Sections 607.1105 and 607.1107 of the Florida Business Corporation Act (the "Florida Statutes"), the undersigned corporations adopt the following Articles of Merger and certify as follows:

- 1. The plan of merger is as follows:
 - (a) AMERICA LIVE! AT FT. LAUDERDALE I, INC. ("ALAF"), a Texas corporation will be merged with and into WORLD MARDI GRAS AT FT. LAUDERDALE I, INC. ("WMG"), a Florida corporation, and WMG will be the surviving corporation.
 - (b) All of the outstanding shares of capital stock of ALAF will be cancelled.
 - (c) The outstanding capital stock of WMG will not be affected by the merger.
- 2. The effective date (the "Effective Date") of the merger is the later of (i) the filing of these Articles of Merger with the Florida Department of State in accordance with the FBCA and (ii) the issuance of a certificate of merger by the Texas Department of State after the filing of Articles of Merger with the Texas Department of State.
