# **ARTICLES OF INCORPORATION**

OF

# **ANDREONE & SALERNO, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### **ARTICLE I - NAME**

The name of the Corporation is: ANDREONE & SALERNO, INC.

### ARTICLE II - DURATION

The duration of the Corporation is perpetual.
