ARTICLES OF INCORPORATION
OF
ZOILA M. ALLEN, M.D., P.A.

The undersigned subscriber to these Articles of Incorporation who is duly licensed to practice medicine in the State of Florida, desires to form a professional corporation for profit under the laws of the State of Florida, and adopts the following Articles for such professional corporation.

ARTICLE I - NAME

The name of this professional corporation is: ZOILA M. ALLEN, M.D., P.A.

ARTICLE II - NATURE OF BUSINESS

The general nature of business to be transacted by this professional corporation is the rendering of medical services. In connection with the above-mentioned purpose, this professional corporation shall have power to invest its funds in real estate, mortgages, stocks, bonds or any other type of investments, or own real or personal property necessary for the rendering of professional services, and do all other acts permitted under the laws of the United States and under the laws of the State of Florida.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock this professional corporation is authorized to have outstanding at any time is one hundred (100) shares of common stock, each share having the par value of One Dollar \$1.00).

ARTICLE IV - TERM OF EXISTENCE

The professional corporation shall have perpetual existence.

ARTICLE V - REGISTERED AGENT



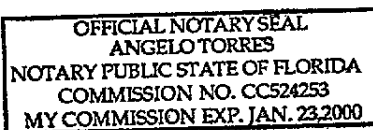
