Initial Board of Directors


This corporation shall initially have two (2) directors. The number of directors may be increased or decreased from time to time



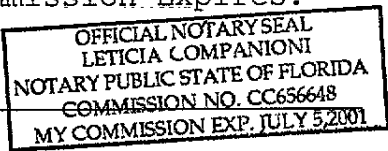


