The name of the corporation shall be UST CONSTRUCTION, INC.

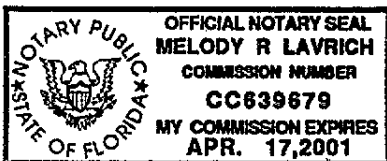
