The undersigned, for the purpose of forming a corporation for profit under the avoid of Florida, hereby adopt the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is HODGES BLVD. ACE HARDWARE, INC.

ARTICLE II

Principal Office
