ARTICLE I

The name of the corporation is Southeastern Medical and Diagnostic Services, Inc.

ARTICLE II

The corporation shall be a sub-chapter "S" corporation for Internal Revenue Service purposes.

ARTICLE III

The general purpose of the corporation is to function as a medical practice, diagnostic and chiropractic service and to transact all lawful business permitted under the Florida General Corporation Act.

ARTICLE IV

The maximum number of shares of stock to be issued by the corporation shall be 60.

ARTICLE V

ARTICLE VI

ARTICLE IX

The Incorporator of the Corporation assigns to this Corporation her rights under section 607.161, Florida statutes, to constitute a corporation and she assigns to those persons designated by the Board of Directors any rights she may have as Incorporator to acquire any of the capital stock of the corporation, this assignment becomes effective on the date corporate existence begins.

ARTICLE X

I, Tammy Conners, hereby accept the position of Registered Agent of Service for the Corporation this 4th day of Sept, 1998.
