I am writing to request that my corporation be reinstated and that the late filing fees be waived. Please find enclosed my application for reinstatement.

We spoke with Tyrone Scott on January 23, 2004, and asked if an exception could be made to the late filing fees. He said to send a check for \$450, \$150 each for years 2002, 2003 and 2004, which I have enclosed, and to write a letter explaining the situation.

If you will look at my records since incorporating in 1998, I filed timely in 1999, 2000 and 2001, but I never received the annual report for 2002. This resulted in my failure to file, and the State administratively dissolving my corporation. Naturally, I did not get a notice the following year. It was not until my accountant called my attention to the fact that for 2004, post cards were being sent and that I might file on-line, that we discovered the problem.

I respectfully request that the late filing fees be waived. I am quite certain that this problem will never occur again. Your assistance with this matter is greatly appreciated.
