ARTICLES OF INCORPORATION OF VORTEX INSIGHT TECHNOLOGY INTERNATIONAL & ASSOCIATES, INC.

ARTICLE 1 - NAME

The name of this corporation shall be Vortex Insight Technology International & Associates, Inc.
