ARTICLES OF INCORPORATION  
OF  
O.H.M. LABORATORIES, INC.

The undersigned, for the purpose of forming a corporation, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is O.H.M. Laboratories, Inc., and its address is 6544 West Atlantic Boulevard, Margate, Florida 33063.

The duration of the corporation is perpetual.



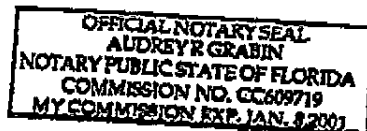
