ARTICLES OF INCORPORATION OF STATE SECRETARY OF STATE OF

The undersigned incorporator(s) for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I
