
ARTICLE VIII - POWERS

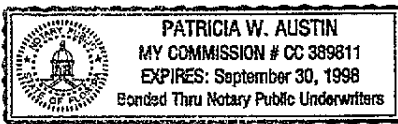
