## ARTICLE NINE. AMENDMENT



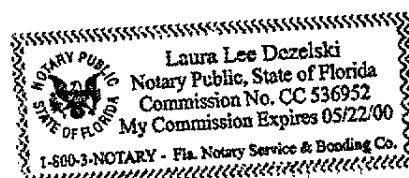


