ARTICLES OF INCOPERATION
OF
SPORTS MEDIA GROUP, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I Name

The Name of the corporation shall be:

SPORTS MEDIA GROUP, INC.

ARTICLE II Nature of Business

This corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, or nation.

ARTICLE III Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is One Hundred and Eighty Thousand shares of common stock having a par value of \$.001 cent per share.

ARTICLE IV Address

The street address of the principal office of the corporation shall be 2905 Brookhaven View, NE Atlanta, Georgia 30319. The street address of the initial registered office of the corporation shall be 2207 71st Street West, Bradenton, Florida 34209 and the name of the Registered Agent for the corporation at that address is:

ARTICLE VI Term of Existence

This cooperation shall exist perpetually.

ARTICLE V Special Provisions

The stock of this corporation is intended to qualify under the requirements of section 1244 of the Internal Revenue Code and the regulation issued thereunder. Such actions as may be necessary, shall be deemed to have been taken by the appropriate officer to accomplish this compliance.

ARTICLE VII Limitation of Liability

Each director, stockholder, and officer, in consideration of his service, shall in the absence of fraud, be indemnified, whether then in office or not, for the reasonable cost and expense incurred by him in connection with the defense of, or for the advise concerning any claim asserted or proceedings brought against him for any reason of his being or having been a director, stockholder or officer of the corporation or of any subsidiary of the corporation, whether or not wholly owned, to the maximum extent permitted by law. The foregoing right of the indemnification shall be inclusive of any other rights to which any director, stockholder, or officer may be entitled as a matter of law.

ARTICLE VII Self Dealing

No contract or other transaction between the corporation and other corporations, in absence of fraud, shall be affected or invalidated by the fact that any one or more of the directors of the corporation is or are interested in a contract or transaction, or are director or officers of any other corporation, and any director or officer, individually, or jointly, may be a party or parties to, or may be interested in such contract, act, transaction, or in any way connected with such persons or persons firm or corporation, and each and every person who may become a director of the corporation is hereby relieved from any liability that may exist from this contracting with the corporation for the benefit of himself or any firm, association or corporation in which he may be in any way interested. Any director of the corporation without regard to the fact that he is also a director of such a subsidiary or corporation.

The corporation shall have a minimum of one director.
The initial Board of Directors shall consist of:


