ARTICLE I-- CORPORATE NAME

The name of this corporation shall be: SOUTHERN NIGHTS ENTERTAINMENT CORPORATION, whose address is 13254 Heather Ridge Loop, Ft. Myers, Florida 33912.

ARTICLE II--PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is 13254 Heather Ridge Loop, Ft. Myers, Florida 33912.

ARTICLE III--CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 20,000 shares of no par value stock.

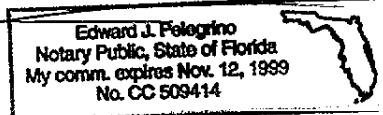


