

1. Don Palmer is the President of SOUTHERN NIGHTS ENTERTAINMENT CORPORATION, a Florida corporation, (hereinafter "Corporation").
2. That the Corporation was administratively dissolved by the Florida Department of State on 19 September 2003.
3. That the Corporation failed to file its 2003-2005 Annual Report or pay the 2003-2005 Annual Report filing fee within the time prescribed by Florida Statutes Chapter 607 because:

6. No further ground or grounds exist for the administrative dissolution of the Corporation.
