# ARTICLES OF INCORPORATION

The undersigned incorporator to these Articles of Incorporation, a natural, person competent to contract, and duly licensed for a music and internet business, and all other related services, hereby forms a Professional Association for profit pursuant to the provisions of the Professional Service Corporation Act and other laws of the State of Florida.

# ARTICLE I

# <u>Name</u>

The name of this corporation is: DIAPASON MUSIC, INC..

# ARTICLE II

# **Existence**

The corporation's existence shall commence on September 15, 1998.

# ARTICLE III

# Nature of Corporate Business and Powers

The general nature of the business to be transacted by this Corporation shall be:

- A. To engage in every aspect and phase of the music and internet industry.
- B. To invest and reinvest the funds of this corporation in real estate, mortgages, stocks, bonds of any other type of investments within the meaning of Chapter 621.08, Florida Statutes, and to acquire and own real and personal property necessary for the rendering of related services.

- B. To invest and reinvest the funds of this corporation in real estate, mortgages, stocks, bonds of any other type of investments within the meaning of Chapter 621.08, Florida Statutes, and to acquire and own real and personal property necessary for the rendering of professional services in the practice of law.
- C. To do each and every thing necessary and proper for the accomplishment or furtherance of any of the purposes or objects of this corporation enumerated in these Articles of Incorporation, or amendment thereof, necessary or incidental to the protection and benefit of this corporation; and, in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful pursuits necessary or incidental to the accomplishment or furtherance of such purposes or objects of this corporation.
