**ARTICLES OF INCORPORATION**  
**OF**  
**KORONA ENTERPRISES, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of this corporation is KORONA ENTERPRISES, INC.

**ARTICLE II - DURATION**

This corporation shall have a perpetual existence, commencing on the day of filing these Articles of Incorporation with the Secretary of State.

**ARTICLE III - PURPOSES**

The general purposes for which this corporation is organized are to engage in and transact any and all lawful acts, activities, and businesses for which a corporation may be incorporated under the Florida General Corporation Act, and to do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.




