

#### ARTICLE I: NAME

The name of this corporation is **LLOYD HONICKMAN**, **CPA**, **P.A**. The mailing address of the corporation is 6514 Springbottom Way, Boca Raton, Florida 33433.

#### ARTICLE II: DURATION

This corporation shall have perpetual existence.

#### ARTICLE III: PURPOSE

This corporation is organized to transact business as a certified public accounting firm and to conduct any lawful business for which a certified public accounting firm may be incorporated under Chapter 621 of the Florida Statutes: Personal Service Corporations and Limited Liability Companies.

## ARTICLE IV: CAPITAL STOCK
