ARTICLE I: NAME

The name of this corporation is **LLOYD HONICKMAN, CPA, P.A.** The mailing address of the corporation is 6514 Springbottom Way, Boca Raton, Florida 33433.

ARTICLE II: DURATION

This corporation shall have perpetual existence.

ARTICLE III: PURPOSE

This corporation is organized to transact business as a certified public accounting firm and to conduct any lawful business for which a certified public accounting firm may be incorporated under Chapter 621 of the Florida Statutes: Personal Service Corporations and Limited Liability Companies.

ARTICLE IV: CAPITAL STOCK

This corporation is authorized to issue One Thousand (1,000) shares of One Cent (\$.01) par value common stock which shall be designated "Common Shares."

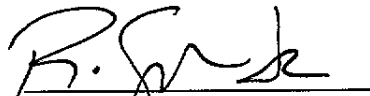
