The undersigned incorporate to those Articles of Incorporation a Florida corporation, hereby for a corporation under the laws of the State of Florida.



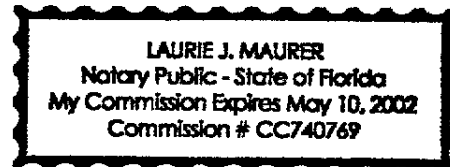
