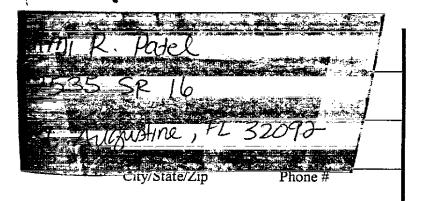

ARTICLES OF INCORPORATION

For the purpose of forming a for profit corporation pursuant to Chapter 607, Florida Statutes, the undersigned hereby adopts the following Articles of Incorporation:

ARTICLE I: CORPORATE NAME

The name of this corporation is SILVER LINING VENTURES, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

Silver Lining Ventures, Inc. 2535 State Road 16 St. Augustine, FL 32092



ARTICLE III: DURATION

SILVER LINING VENTURES, INC.. ("Silver Lining") shall perpetually exist beginning with the filing of these Articles of Incorporation with the Division of Incorporation of the State of Florida.

ARTICLE IV: PURPOSE

Silver Lining is organized for the purpose of transacting any and all lawful business.

ARTICLE V: CAPITAL STOCK

Silver Lining is authorized to issue 5,000 shares of \$1.00 par value common stock. Upon the sale for cash of any new stock of Silver Lining of the same kind, class or series as that which he or she already holds, every shareholder shall have the right to purchase his or her pro rate share (as nearly as may be done without issuing fractional shares) at the price at which it is offered to others. Each shareholder of Silver Lining shall have the first right to purchase shares (and any securities convertible into shares) of any class, kind or series of stock in this corporation that may from time to time be issued (regardless of whether presently authorized), including shares from the treasury of Sterling, in the ratio that the number of shares he or she holds at the time of issue bears to the total number of shares outstanding, exclusive of treasury shares. This right shall be deemed waived by any shareholder who does not

exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from Silver Lining setting the prices terms and conditions of the issues of shares, and inviting him or her to exercise his or her preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to Silver Lining within thirty (30) days of receipt of notice from Silver Lining.

ARTICLE VI: QUORUM FOR STOCKHOLDERS MEETINGS

Unless otherwise provided for in the corporation's bylaws, a minimum of seventy-five percent (75%) of all shares entitled to vote, represented in person or by proxy, shall be required to constitute a quorum at a meeting of shareholders.

ARTICLE VII: INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of Silver Lining Ventures, Inc. is 2535 State Road 16, St. Augustine, Florida 32092. The initial registered agent of Silver Lining at that address is Ami R. Patel.

ARTICLE VIII: INITIAL BOARD OF DIRECTORS

Silver Lining shall initially have five directors. The number of directors may be increased or decreased from time to time in a manner provided in the bylaws, but shall never be less than one. The name and address of the initial directors of Silver Lining are the following:
