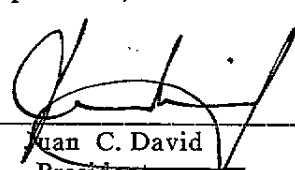
1. ARTICLE 1 of the Articles of Incorporation of SCHINDLER AND PARTNERS, INC. amended to read as follows:

NAME

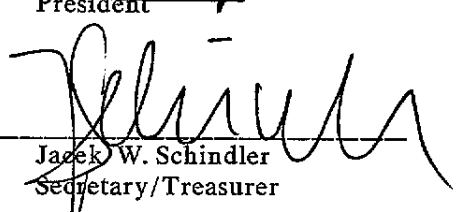
The name of the corporation is:

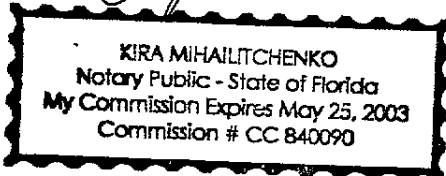

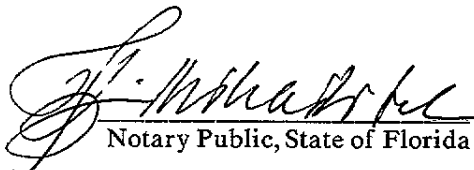
