The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a professional service corporation under Chapter 621 of the laws of the State of Florida.

ARTICLE I.

NAME: The name of this corporation shall be VICTOR L. DeLUCAS, D.M.D. - P.A.

ARTICLE II.
