ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment(s) adopted:

I, Dorothy Levine, President of Seller's Realty Network, Inc., a Florida Corporation do hereby certify that pursuant to a joint Corporate Action by Shareholders and Directors of Seller's Realty Network, Inc., dated the 21st day of September, 1999, the following was unanimously agreed and adopted and approved:
