

Articles Of Amendment Of Karen Lloyd Real Estate, Inc.

The Articles of Incorporation of the above named corporation are amended as follows so as to conform the above referenced corporation as a Professional Service Corporation for profit by virtue of the provisions of Chapter 621, Florida Statutes:

- 1. The name of the corporation is Karen Lloyd Real Estate, P.A.
- 2. Article IV Purpose is deleted in its entirety and replaced with the following:

The general nature of business and the proposed objects and purposes to be transacted, promoted and carried on by the corporation are to do any and all things hereinafter mentioned as fully and to the same effect and extent as natural persons might or could do under the laws of the State of Florida, viz.,

- A. To engage in every aspect of the practice of real estate and all its fields of specialization as are engaged in by realtors in this state.
