ARTICLES OF INCORPORATION

OF

BACHTEL DISTRIBUTING, INC.

ARTICLE I - NAME:

The name of this corporation is: BACHTEL DISTRIBUTING, INC.
hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing on the filing of the Articles of Incorporation with the Department of State of State.

ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of engaging in the Package Delivery business and for the purpose of transacting any or all other lawful business not inconsistent with the Laws of the State of Florida.


ARTICLE IX -- BY-LAWS:
