

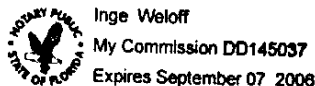
1. Ersun Yergin is the President of WHITE TULIP FLORIST CORP., a Florida corporation, (hereinafter "Corporation").


