ARTICLES OF INCORPORATION OF LITTLE ANGELS CHRISTIAN ACADEMY, INC.

ARTICLE I - NAME

The name of this corporation is LITTLE ANGELS CHRISTIAN ACADEMY,/a

Florida corporation.
