

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Affordable Transport & Setup Services, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 11302 N. Nebraska Avenue Tampa, Florida 33612

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of no par value common stock which shall be designated as "Common Shares".
