EFFECTIVE DATE

Know All Men By These Presents: That the undersigned incorporators does hereby incorporate a corporation under the provisions of Chapter 607, Florida Statutes, not for profit with and under the following Articles of Incorporation:

#### Article I

The name of the corporation shall be and is **Joint Association Certification Committee**, Inc.

#### Article II

The duration of the corporation shall be and is perpetual, and the date and time of the commencement of the corporation's existence shall be and is the A.D. 1998.

#### Article III

The general purposes for which the corporation is initially organized are as follows:

- a) To transact any or all lawful business for which corporation may be incorporated under Chapter 607, Florida Statutes.
