of
Joint Association Certification Committee, Inc.**

Know All Men By These Presents: That the undersigned incorporators does hereby incorporate a corporation under the provisions of Chapter 607, Florida Statutes, not for profit with and under the following Articles of Incorporation:

Article I

The name of the corporation shall be and is **Joint Association Certification Committee, Inc.**

Article II

The duration of the corporation shall be and is perpetual, and the date and time of the commencement of the corporation's existence shall be and is the September 7 A.D. 1998,.

Article III

The general purposes for which the corporation is initially organized are as follows:

- a) To transact any or all lawful business for which corporation may be incorporated under Chapter 607, Florida Statutes.
- b) To establish and maintain the designation Florida Certified Investigator (FCI).
- c) To affirm the professionalism and credibility of the individual Florida Private Investigator.
- d) Requiring continuing education to maintain high standards of the FCI designation.

Article IV

The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1,000), all of which shall be of one and the same class and each of which shall be of the par value of One Dollar (\$1.00) per share.

Article V

The street address of the corporation's initial registered office is 4111 Metric Drive, Winter Park, Florida 32792. The name of the corporation's initial registered agent at said address is Michael A. McDonald. The principal office and registered office shall be identical.

Article VI

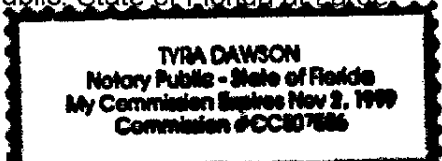
