ARTICLES OF INCORPORATION OF PLANTERS PLANTATION GOLF, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I <u>NAME</u>

The name of the corporation is PLANTERS PLANTATION GOLF, INC., (hereinafter called the "Corporation").

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS
