**ARTICLES OF DISSOLUTION

Pursuant to the provisions of Section 607.1401 of the Florida Business Corporation Act, Planters Plantation Golf, Inc. a Florida corporation (the "Corporation"), hereby files the following Articles of Dissolution for the purpose of dissolving the Corporation:

1. The name of the Corporation is: Planters Plantation Golf, Inc.
2. The Articles of Incorporation for the Corporation were filed on September 1998 (document no. P98000078711).
3. The dissolution was authorized by the sole Incorporator of the Corporation on September 18, 1998.
