**ARTICLES OF INCORPORATION OF
ARY CHOUKE, P.A.**

The undersigned incorporator, who is licensed or otherwise legally authorized to practice the profession of law in the State of Florida, with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopts the following articles of incorporation for the corporation:

**ARTICLE I.
NAME**

The name of the corporation is: **Ary Chouke, P.A.**

**ARTICLE II.
PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT**

The address of the corporation's principal place of business is 777 Arthur Godfrey Road, Second Floor, City of Miami Beach, County of Dade, State of Florida, 33140. The name of the initial registered agent of the corporation, located at that office, is Ary Chouke, Esq.

**ARTICLE III.
DURATION**

The period of the corporation's duration shall be perpetual or until dissolved on a vote of the shareholder(s).

**ARTICLE IV.
PURPOSE**

The general purpose of the corporation is to practice the profession of law. The corporation shall also have the right to transact all other business which the corporation is not prohibited to transact under the Florida Professional Service Corporation and Limited Liability Company Act.

ARTICLE V.
CAPITAL STOCK

The total number of shares of stock which the corporation shall be authorized to issue or have outstanding at any one time is one hundred (100) shares. These shares shall be of a single class of common stock and shall have a value of Ten Dollars (\$10.00) per share.

ARTICLE VI.
CAPITALIZATION

The amount of capital with which the corporation will begin to practice the profession of law is not less than One Thousand Dollars (\$1,000.00).

ARTICLE VII.
CORPORATE POWERS

The corporation shall have all the rights and powers now or subsequently conferred on professional corporations by the laws of the State of Florida.

ARTICLE VIII
INCORPORATOR

The name and street address of the person signing these articles of incorporation as an incorporator are:

ARTICLE IX.
DIRECTORS

The corporation is to be managed by a board of directors. The number of directors constituting the initial board of directors is one (1) and the name and address of the initial director is: -----

The initial director shall hold office until his successor is elected and qualified as provided in the bylaws. Thereafter, the term of office of each director shall be one year or until the election and qualification of a successor. The number of directors for the corporation shall be as aforementioned until that number is changed pursuant to the bylaws.

ARTICLE X. BYLAWS

The initial director shall submit the proposed bylaws to the shareholder(s) at a meeting to be held for that purpose not more than forty-five (45) days following the date of issuance of the Certificate of Incorporation. Following the adoption of bylaws by the affirmative vote of three-fourths (3/4) of the shareholders, the internal affairs of the corporation are to be regulated and managed in accordance with the bylaws.


